OLD BUSINESS:

1. JOSEPH DILIBERTO BOR DKT. 00228111

Claimant appealed denial of Pandemic Unemployment Assistance (PUA) benefits as the claim was invalid on the ground the claimant did not have a Labor Market attachment, or earnings in 2019 and liable for non-fraud refund. **(This case was tabled in the meeting of April 28, 2021 to review the merits, as the claimant's appeal was timely to the Board of Review.)**

ACTION: BOARD VOTED TO REMAND THIS MATTER TO THE APPEAL TRIBUNAL FOR EVIDENCE OF A BONAFIDE OFFER OF WORK TO SHOW ATTACHMENT TO THE LABOR MARKET.

2. KIMBERLIE CHARLES BOR DKT. 00216112

Claimant appealed a decision of the Appeal Tribunal holding a disqualification for Disability During Unemployment benefits on the ground that the claimant left the work voluntarily without good cause attributable to such work. **(This case was tabled in the meeting of October 28, 2020 to obtain original documentation.)**

ACTION: BOARD VOTED TO AFFIRM THE APPEAL TRIBUNAL DECISION.
